

M-Files Compliance Kit December 2021 Update Service Release 8 (21.12.1057.19) Release Notes

Note! There is unsigned and signed version of M-Files Compliance Kit December 2021 Update Service Release 8. The versions have different compatibility requirements (see below).

(Unsigned) M-Files Compliance Kit December 2021 Update and its (unsigned) service releases are compatible with M-Files Online - September '21 Update and M-Files 2018 - Update 2109 or newer.

Signed M-Files Compliance Kit December 2021 Update Service Release 6 and the following signed service releases are compatible with M-Files Online - June '22 Update or newer.

Summary of the fixed issues and improvements in this release:

M-Files Compliance Kit December 2021 Update Service Release 8 (21.12.1057.19)

Defect: Vault structure upgrade fails after update to Compliance Kit 21.12.1057.18

ID: 167017

Symptom: When an admin user installs Compliance Kit 21.12.1057.18 (signed or unsigned) and runs the structure upgrade to most of the modules, the upgrade and change preview fails with the message error "AllowSignedCustomCodeInImport - not implemented".

Solution: Fixed.

M-Files Compliance Kit December 2021 Update Service Release 7 (21.12.1057.18)

Defect: PDF Processor may run out of memory converting a Word document to PDF.

ID: 164656

Symptom: The PDF Processor may run out of memory when converting a Word document to PDF if it contains references that contain other references.

Solution: Fixed.

Improvement: Control barcode and image overlay size in PDF renditions.

ID: 165105

Description: It is now possible to choose the exact height and width (in points) that will be used when defining an image or barcode overlay.

Improvement: Support for many source objects in Object Creator in the classic web

ID: V-62715

Description: It is now possible to select several objects and create a single object that combines the selected objects with the Object Creator module. Note: This improvement requires M-Files Web version 22.11.11950 or later.

Improvement: Support for many source objects in Object Creator in M-Files Desktop

ID: 155652

Description: It is now possible to select several objects and create a single object that combines the selected objects with the Object Creator module.

Improvement: Vault Application Framework (VAF) upgrade

ID: 162864, 162738, 162895, 162255

Description: VAF version used in Compliance Kit was upgraded from 2.3.623.6 to 2.3.623.9.

Defect: Cannot make state transition in new or classic web

ID: 164656

Symptom: A user cannot change the object state in the new or classic M-Files Web if an auto-calculated property rule configured in the Managed Properties module changes a property value. This occurs only if the user does not have edit rights to the object.

Solution: Fixed.

Defect: Filter condition not working

ID: 162864

Symptom: When a user tries to check in an object, the operation sometimes fails with the unspecified error message. This occurs when there is a filter condition configured in the Managed Properties module for AutoCalculatedProperties that compares the "<Property> (any property)" property with the "Is empty or missing" expression.

Solution: Fixed.

Defect: Auto-calculated properties not updated correctly in Managed Properties

ID: 166366

Symptom: In the Managed Properties module, auto-calculated properties are updated correctly only when a vault extension method is called for the first time. The next method calls do not update the auto-calculated properties.

Solution: Fixed.

Defect: Date not correct in rendered PDF when Version Control is used

ID: 165588

Symptom: Server is set to a minus time zone. For example, UTC -10:00. There is an M-Files object with a date property that is inserted into a Word document. When the Word document is rendered to PDF with the Version Control module, the date in the PDF is one day behind. For example, if the date property has the value 30.1.2023 on the metadata card, the PDF has the date 29.1.2023.

Solution: Fixed.

Defect: Version Control ignores deletion events

ID: 164739

Symptom: When a controlled document is deleted, the Version Control module makes sure that the operation is allowed and that the related objects are also deleted. However, if the document has "Is Record" set to Yes, Compliance Kit ignores the checks, and the document is deleted without correct cleanup.

Solution: Fixed.

Defect: Cannot generate preview for metadata card configuration changes in new cloud

ID: 166264

Symptom: Compliance Kit is installed to M-Files Cloud and there are one or more metadata card configuration rules defined. When an admin selects the "Generate preview" option in the "Upgrade Vault Structure" section, the operation fails with the error message "An error occurred during a call to extension function 'GetXMLFromLocalVault'. See InnerException for a complete description of the error".

Solution: Fixed.

M-Files Compliance Kit December 2021 Update Service Release 6 (21.12.1057.10)

Defect: Low disk space in Azure causes missing exported log files missing

ID: 163571

Symptom: Azure File Share export provider does not report an error when the export cannot be completed because of low disk space. The export continues but no logs are exported.

Solution: Fixed.

Defect: The Managed Properties module does not allow read-only users to change the workflow state in M-Files Web and the classic M-Files Web

ID: 161682

Symptom: The Managed Properties module causes an unnecessary error message to be shown to read-only users. This happens when they try to change the workflow state of an object in M-Files Web and the classic M-Files Web.

Solution: Fixed.

Defect: Log exporter causes a delay with the M-Files Desktop login

ID: 163990

Symptom: When the log exporter is in use, login to M-Files Desktop can be delayed.

Solution: Fixed.

Defect: PDF text overlays can have unwanted gray dots

ID: 163542

Symptom: When Compliance Kit is used to generate PDFs with an overlay text, they can contain gray dots in the lower left corner of the stamps.

Solution: Fixed.

M-Files Compliance Kit December 2021 Update Service Release 5 (21.12.1057.8)

Improvement: Setting for Version Control Lite to not add automatic comments

ID: 162761

Description: The Version Control Lite module can now be set to not add an automatic object comment with versioning actions.

Defect: Compliance Kit applications incompatible with older clients

ID: 162922

Symptom: Compliance Kit client applications do not operate on clients that do not support the "[fast browsing](#)" mode.

Solution: Fixed.

Defect: Current user based conditions for Object Creator do not operate correctly in the classic M-Files Web

ID: 162756

Symptom: Filter conditions based on the current vault user and given to the Object Creator module do not operate correctly in the classic M-Files Web.

Solution: Fixed.

Defect: Object Creator cannot sometimes create objects

ID: 160774

Symptom: The Object Creator module does not create the object and reports this error instead: "The ObjVer string 'null' is not valid."

Solution: Fixed.

Defect: Managed Properties can cause a conflict with FileVersion

ID: 163092

Symptom: When the Managed Properties module updates an object, and then the FileVersion property is updated, a conflict can occur.

Solution: Fixed.

M-Files Compliance Kit December 2021 Update Service Release 4 (21.12.1057.5)

Defect: PDF Processor does not try PDF generation again after transient errors

ID: 162750

Symptom: When transient errors occur while the PDF Processor module generates or checks in a PDF rendition, the task fails, and it is not retried or requeued.

Solution: Fixed.

Defect: Invalid digital signatures in PDF renditions

ID: 162642

Symptom: A PDF rendition instruction includes PDF restrictions and digital signatures. When the PDF Processor module creates the PDF rendition, the digital signatures become invalid.

Solution: Fixed.

Defect: "Related Object Rules" settings cause an error during login

ID: 162717

Symptom: When the "Related Object Rules" settings in the UI Configuration module are not specified, an error is shown to users when they log in to M-Files Desktop.

Solution: Fixed.

M-Files Compliance Kit December 2021 Update Service Release 3 (21.12.1057.4)

Defect: Cannot use Audit Log Viewer because of corrupt log files

ID: 162411

Symptom: If there are corrupt log files, Audit Log Viewer cannot be opened. When a user tries to open it from M-Files Desktop, an error is shown.

Solution: Fixed.

M-Files Compliance Kit December 2021 Update Service Release 2 (21.12.1057.3)

Improvement: PDF Processor now supports OpenDocument documents

ID: 161871

Description: PDF Processor can now convert OpenDocument documents to PDF.

Defect: Related object hierarchy rules in Advanced Vault Settings get overridden unexpectedly

ID: 162177

Symptom: An empty list of related object hierarchy rules in the Configuration UI module overrides similar rules defined in the Advanced Vault Settings section.

Solution: Fixed.

Defect: Cannot use Audit Log Viewer from M-Files Desktop

ID: 162071

Symptom: When a user opens Audit Log Viewer from M-Files Desktop, an error is shown.

Solution: Fixed.

Defect: Cannot update file version of object created from template

ID: 162111

Symptom: When a user creates an object from a template whose version is greater than one, the File Version feature in the Utilities module shows an error.

Solution: Fixed.

Defect: PDF conversion fails randomly

ID: 161742

Symptom: PDF conversion can fail with high parallelism.

Solution: Fixed.

Defect: Links in upgrade vault structure preview not working

ID: 160603

Symptom: When a user clicks a link in the upgrade vault structure preview, an error is shown.

Solution: Fixed.

M-Files Compliance Kit December 2021 Update Service Release 1 (21.12.1057.2)

Defect: Log Exporter target configuration is lost

ID: 161795

Symptom: When Compliance Kit is upgraded in cloud environment, the Log Exporter target configuration is lost, and manual reconfiguration is necessary.

Solution: Fixed.

Defect: Hierarchy Manager keeps objects checked out during upgrade

ID: 161745

Symptom: When several asynchronous Hierarchy Manager rules have been triggered and a new Compliance Kit version is installed, triggered objects sometimes stay checked out. If the admin runs "Check for Transition Errors" for the failed objects, the Failed Transitions dashboard is not opened.

Solution: Fixed.

M-Files Compliance Kit December 2021 Update (21.12.1057.1)

Improvement: Improvements to Multi-Server Mode support

ID: V- 42411

Description: Tasks are now processed much more reliably in Multi-Server Mode. Compliance Kit now also supports Multi-Server Mode in New Cloud setups.

Improvement: Improved Compliance Kit upgrade process

ID: 161515

Description: The Compliance Kit upgrade process now ensures all background task processing is paused during upgrade and that two versions of the application are not running at the same time on different server instances in Multi-Server Mode.

Improvement: Fast browsing functionality now supported in Compliance Kit and Home Screen applications

ID: 158554

Description: The Compliance Kit user interface and the Home Screen applications now support the fast browsing functionality.

Improvement: Clearer error message for metadata rendition instructions that refer to a value list

ID: 158611

Description: The error message was improved in situations where the metadata rendition instruction's merge property refers to a value list instead of an object type."

Improvement: Improved filtering options for the configuration of some modules

ID: 159229

Description: The filtering options have now been improved in the metadata structure configuration of some Compliance Kit modules.

Improvement: Different time zones cause problems with date comparison in Log Exporter

ID: 159903

Description: Date comparison for the Log Exported module does not work because the exported timestamps and the timestamps of the events use different time zones.

Improvement: Setting to control whether overlay fonts are embedded to PDF renditions

ID: 161517

Description: You can now control whether the font used by an overlay is embedded to PDF renditions.

Defect: "Null reference" exceptions for PDF rendition instructions

ID: 157056

Symptom: A PDF rendition instruction with no value for the Custom Rendition Key setting in the configuration of the PDF Processor module can cause "null reference" exceptions.

Solution: Fixed.

Defect: Document rendition instructions do not update the properties of the target object

ID: 149517

Symptom: Processing of document rendition instructions does not update the properties of the target object based on "Copy Properties" settings when the target object already exists.

Solution: Fixed.

Defect: Vulnerability in Object Creator

ID: 157776

Symptom: A vulnerability in the Object Creator module can cause data security issues.

Solution: Fixed.

Defect: PDF processing can add unnecessary characters to bookmarks

ID: 159587

Symptom: PDF processing with prepending or appending PDF processing instructions can add unnecessary euro (€) characters to the bookmarks of the resulted PDF.

Solution: Fixed.

Defect: Word to PDF conversions can create incorrect headers

ID: 161126

Symptom: A Word document has a different header for the first page and for the second page. In PDF processing, the header of the first page can be replaced with the header of the second page.

Solution: Fixed.

Defect: PDF conversions do not work correctly for Excel cells that contain the STDEV.S or STDEV.P function

ID: 158610

Symptom: PDF conversions for Excel cells that contain the STDEV.S or STDEV.P function causes the cells to show the error "#NAME?".

Solution: Fixed.

Defect: Unnecessary "No action" option in configuration for Managed Properties

ID: 157116

Symptom: A "No action" option unnecessarily shown in the configuration of automatic property calculation for the Managed Properties module.

Solution: Fixed.

Defect: Schemes no edits cause an "invalid pointer" error

ID: 157142

Symptom: If a Version Control scheme is saved with no edits, an "invalid pointer" error is shown.

Solution: Fixed.

Defect: Module status not up to date in M-Files Admin

ID: 157257

Symptom: The module status shown in the upper-right corner of the configuration area in M-Files Admin is not always up to date.

Solution: Fixed.

Defect: User Synchronization does not synchronize with background synchronization

ID: 157582

Symptom: The User Synchronization module does not synchronize with background synchronization. After a vault is taken offline and restarted, background synchronization does not restart.

Solution: Fixed.

Defect: User Synchronization status shown inconsistently in dashboard

ID: 157234

Symptom: The status of the User Synchronization module is shown inconsistently in the dashboard. The dashboard incorrectly claims that no synchronization has been done. The Synchronize Users button does not update the status.

Solution: Fixed.

Defect: Status of servers shown incorrectly in Multi-Server Mode

ID: 157285

Symptom: The status of all servers is not always shown correctly in the Compliance Kit dashboard when Multi-Server Mode is used. The dashboard for Availability Group Health Status can report about additional groups, or not all servers are listed.

Solution: Fixed.

Defect: Rule error with deleted reference in Hierarchy Manager

ID: 157465

Symptom: There is a prevention rule in the Hierarchy Manager module that tries to check document properties with a referencing property. If the document with the referenced property is deleted, the check is unsuccessful and the "not found" error message is shown.

Solution: Fixed.

Defect: Messages sent by Advanced Notifications can contain out-of-date property values

ID: 157874

Symptom: Messages sent by the Advanced Notifications module can contain property values that are out of date.

Solution: Fixed.

Defect: Cannot roll back documents when the File Version property is used

ID: 152130

Symptom: The vault contains documents that use the File Version property. When a user tries to roll back a document that has its metadata changed, the operation cannot be completed, and this error message is shown: "The action was denied because the property 'File Version' was not updated correctly. To fix the issue, install workflow state action script."

Solution: Fixed.

Defect: Cannot use complex sequences with the Utilities module

ID: 157876

Symptom: Complex sequences cannot be used with the Utilities module. The error message "Parameter is incorrect" is shown instead.

Solution: Fixed.

Defect: Validation findings not updated after installing Home Screen

ID: 157902

Symptom: Validation findings are not updated after the Home Screen application is installed in the UI Configuration dashboard.

Solution: Fixed.

Defect: Managed Properties used with User Synchronization can cause an error

ID: 158294

Symptom: In some cases, if used with the User Synchronization module, the Managed Properties module causes this error: "The value '0' does not exist, or it is a conflict object."

Solution: Fixed.

Defect: Check-ins cannot be done for objects with the File Version property after M-Files is upgraded

ID: 156097

Symptom: After an M-Files upgrade, check-ins can sometimes not be completed. This happens if an object uses automatic updates for embedded metadata on check-in and contains the File Version property.

Solution: Fixed.

Defect: State transitions can cause errors with the Advanced Notification module

ID: 158702

Symptom: A workflow state transition in the Advanced Notifications module can cause this error: "The object is locked. Try again later. Object: <ID>."

Solution: Fixed.

Defect: File downloads from external repositories can stop log exporting

ID: 158150

Symptom: Some "External Repository File Download" events cannot be exported by the Log Exporter module. The module stops with this error message: "Log Exporter process has been stopped due to too many errors. Correct the problem and restart the export process to resume".

Solution: Fixed.

Defect: PDF Processor does not use locale name

ID: 156113

Symptom: The PDF Processor module does not use the Locale Name setting saved to Named Value Storage or Advanced Vault Settings. The server's locale settings are used instead.

Solution: Fixed.

Defect: Header and footer elements in Excel can be rendered incorrectly in PDF renditions

ID: 157232

Symptom: The footer and header elements "File Name" and "File Path" in Excel can be rendered incorrectly in PDF renditions.

Solution: Fixed.

Defect: M-Files can stop operating after Compliance Kit upgrade

ID: 158968

Symptom: Compliance Kit Calendar is configured, and Compliance Kit is upgraded. When a user starts to select objects in M-Files, the Home Screen application can cause M-Files to stop operating.

Solution: Fixed.

Defect: Managed Properties can show sensitive information

ID: 159143

Symptom: The Managed Properties module can show sensitive information.

Solution: Fixed.

Defect: Class cannot be changed with Managed Properties

ID: 159526

Symptom: The user cannot sometimes change the class of an object with the Managed Properties module. This error message is shown instead: "The mandatory property value <value> is missing".

Solution: Fixed.

Defect: Controlled printing dialog is empty in the classic M-Files Web

ID: 158040

Symptom: Controlled printing dialog is empty in the classic M-Files Web if a printout item is not created for a tracking item.

Solution: Fixed.

Defect: PDF renditions incorrectly show all values of embedded multi-select properties

ID: 158681

Symptom: PDF renditions of Word documents show all values of embedded multi-select properties when only one is shown in the Word document.

Solution: Fixed.

Defect: Object Creator cannot create more than 500 objects at once

ID: 159879

Symptom: The Object Creator module cannot create more than 500 objects at once.

Solution: Fixed.

Defect: Opening and closing braces in M-Files paths can cause issues in PDF rendering

ID: 160384

Symptom: Opening and closing braces (curly brackets) in M-Files temporary paths can cause that PDF rendering cannot be completed.

Solution: Fixed.

Defect: Hierarchy Manager can cause problems with check-ins of some object types

ID: 159937

Symptom: The Hierarchy Manager transition rule with "Relationship Property Location" = "Triggered Object" can prevent the check-in of some object types.

Solution: Fixed.

Defect: Recipient cache can become corrupted

ID: 160528

Symptom: The recipient cache of the Advanced Notifications module can in some cases become corrupted.

Solution: Fixed.

Defect: Some filter conditions for notification rules cause errors

ID: 160867

Symptom: Indirect properties in filter conditions of notification rules cause errors if they use alias or GUID references.

Solution: Fixed.

Defect: Advanced Notifications shows Recipients as editable

ID: 160965

Symptom: The rule editor of the Advanced Notifications module shows the Recipients property as editable even in read-only mode.

Solution: Fixed.

Defect: Failed transitions done with Hierarchy Manager cannot be cleared

ID: 161014

Symptom: Failed transitions done with the Hierarchy Manager module cannot be cleared if the triggering object is destroyed.

Solution: Fixed.

Defect: PDF Processor uses incorrect IDs

ID: 160100

Symptom: The PDF Processor module uses internal IDs instead of external IDs.

Solution: Fixed.

Defect: Compliance Kit UI application operates incorrectly after online-offline transitions

ID: 159023

Symptom: The Compliance Kit UI application can show errors or update task pane button visibility incorrectly after online-offline transitions.

Solution: Fixed.

Defect: "Invalid font name" error with PDF A1-a and PDF A1-b formats

ID: 158918

Symptom: PDF conversion cannot be completed, and the "invalid font name" error is shown when PDF A1-a and PDF A1-b formats are processed.

Solution: Fixed.

Defect: LTV signatures cannot be used with PDF/A documents

ID: 161299

Symptom: LTV (long-term validation) signatures cannot be used when the PDF Processor module processes documents in the PDF/A format.

Solution: Fixed.

Defect: Training cannot process rules that refer to non-trainable items

ID: 161303

Symptom: The Training module cannot process rules that refer to non-trainable items.

Solution: Fixed.

Defect: Overlays corrupt in PDF/A documents

ID: 154846

Symptom: Overlays to PDF/A documents causes a corrupt result.

Solution: Fixed.

M-Files Compliance Kit October 2020 Update Service Release 3 (20.10.911.8)

Defect: Workflow issues with Advanced Notifications

ID: 158702

Symptom: The Advanced Notifications module sometimes causes workflow state changes to not operate correctly. An error, such as "object is locked", is shown instead.

Solution: Fixed.

Defect: Task processing does not operate correctly

ID: 157613

Symptom: The Compliance Kit task processing does not work correctly. Windows Event Viewer shows this error message in the event log: "The maximum number of batches is already processing."

Solution: Fixed.

Improvement: Fast-browsing support for Compliance Kit

ID: 158554

Description: There is now a new configuration option to control whether the fast-browsing functionality is used. Use the setting only in environments where the server and clients are of version 20.11 or later.

M-Files Compliance Kit October 2020 Update Service Release 2 (20.10.911.6)

Defect: Significant performance degradation in Compliance Kit

ID: 157750

Symptom: Certain operations in Compliance Kit 20.10 release were significantly slower compared to the older versions.

Solution: Fixed. The fix requires the M-Files 20.12 release or later.

M-Files Compliance Kit October 2020 Update Service Release 1 (20.10.911.5)

Defect: User Synchronization module does not synchronize with background synchronization

ID: 157582

Symptom: The User Synchronization module is configured to use the background synchronization mode. After the vault is restarted, the module does not to restart.

Solution: Fixed.

M-Files Compliance Kit October 2020 Update (20.10.911.3)

Defect: Same barcode generated for all symbology types

ID: 156800

Symptom: The barcode symbology type was always parsed as Code128 in barcode generation, regardless of the actual symbology type that had been defined.

Solution: Fixed.

M-Files Compliance Kit September 2020 Update (20.3.885.33)

Improvement: Multi-Server Mode support for Compliance Kit

ID: F-8054

Description: Multi-Server Mode is now supported in Compliance Kit.

Improvement: PDFTron support for PDF concatenation

ID: 155088

Description: You can now set PDFTron (PDFNet) to be used for PDF concatenation via the PDF Processor configuration.

Improvement: Training module performance improved

ID: 153692

Description: The Training module now uses memory and data caching more efficiently.

Defect: Compliance Kit: Advanced notifications has an issue with advanced search criteria

ID: 153346

Symptom: The advanced notifications preview does not correctly show previews for filter conditions if the filters include the condition "Deleted".

Solution: Fixed.

Defect: PDF Processor does not obey LocaleName

ID: 149711

Symptom: In a rendered PDF, dates are shown in wrong locale format.

Solution: Fixed.

Defect: Utilities sequence fails with Object type condition

ID: 156599

Symptom: When a user tries to check in a document that has "IsTemplate=true" and the document matches a sequence configuration where "Filter Conditions" include the "Object type" check, the check-in fails with the error message "Invalid pointer. (Object reference not set to an instance of an object.)"

Solution: Fixed.

Defect: Compliance Kit: Unique Object Enforcement filters do not work properly

ID: 153952

Symptom: Objects that do not match the "Additional Search Criteria" option in a unique object rule, but match all other criteria, are still found when the user searches for duplicates. This prevents the saving of potentially correct objects.

Solution: Fixed.

Defect: PDF Processor issue with files used by another process

ID: 154980

Symptom: PDF processing sometimes results in the following error: "The process cannot access the file "X" because it is being used by another process."

Solution: Fixed.

Defect: Owner (Person) in the default structure does not have named access control list

ID: 154039

Symptom: When the default structure in the User Synchronization module is used, the property "Owner (Person)" does not have any named access control list (NACL) attached to it. Therefore, if a structure where the "Person Restricted Data" object type is a subordinate to the "Person" object type, normal users cannot create this type of objects. Since the "Owner (Person)" is an automatically created property, you cannot modify the permissions manually.

Solution: Fixed.

Defect: The "is empty or missing" condition not working with Unique Object Enforcement

ID: 152842

Symptom: The "is empty or missing" condition does not work with the Unique Object Enforcement module. When you attempt to save a copy of a document that does not have the "is missing" property, the following error message is shown: "The object "X" cannot be saved. At least one object with the same metadata already exists."

Solution: Fixed.

Defect: Advanced Notifications not sent if the email address contains apostrophes

ID: 154841

Symptom: The Advanced Notifications module does not send notifications to email addresses that contain apostrophes.

Solution: Fixed.

Defect: Session timeout shown when using the Controlled Printing command in M-Files Web

ID: 150113

Symptom: In M-Files Web, when you select a PDF file and click Controlled Printing in the task area, the following error message is shown: "Session has expired. Redirecting to login page."

Solution: Fixed.

Defect: Conversion from PowerPoint to PDF causes black areas to appear

ID: 149137

Symptom: When a user converts a PowerPoint file to a PDF, the resulting PDF has extra black areas.

Solution: Fixed.

Defect: Completing a change request fails

ID: 150099

Symptom: When a user tries to complete a change request with a document that has never been checked in, an error is thrown.

Solution: Fixed.

Defect: Error when using float values as filters in the configurator

ID: 151488

Symptom: When you use float values with JsonAdaptors as filters in the configurator (for example, with Managed Properties of Compliance Kit), saving the configuration fails with a deserialization error.

Solution: Fixed.

Defect: Conversion from PowerPoint to PDF removes charts

ID: 151105

Symptom: When a user converts a PowerPoint file to a PDF, the resulting PDF file does not have charts on the first two slides.

Solution: Fixed.

Symptom: The previously defined "PDFRenditionInstruction" value (can also be a value imported from a full structure) is not recognized because the configuration name has been changed to "PdfRenditionInstruction".
